Have thrown the weight in a competition or attended a USATF clinic this season (allows unlimited entrants from a school)
Or, 2) Statement from coach that the individual has practiced and has been coached in the event (max 2 per school in this category)
Non-Mass throwers allowed as "exhibition" from NH & VT only, same requirements as above, and <u>must</u> enter by Friday February 18.

ORDER OF EVENTS 11:00 a.m. - All throwers check in

11:30 a.m. GIRLS' 20# weight throw

Followed by BOYS' 25# weight throw

<u>COMPETITION</u>: Three throws, with top eight throwers advancing to finals for three additional throws

AWARDS: Medals to top six places in each division, with additional trophies and plaques provided by Twilight Throwers
